

**RESOLUTION NO. 2023-R-99**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER AND CITY  
ATTORNEY TO EXECUTE A MEMORANDUM OF  
UNDERSTANDING BETWEEN THE CITY OF NORTH  
MIAMI AND LOVE.FÚTBOL, INC. FOR THE  
INSTALLATION OF THE LOVE.FÚTBOL PITCH AND  
ENHANCEMENT OF SERVICES AT CAGNI PARK SOUTH;  
PROVIDING FOR AN EFFECTIVE DATE AND ALL  
OTHER PURPOSES.**

**WHEREAS**, Love.fútbol, Inc. (“Love.fútbol”) is an international non-profit organization dedicated to partnering with communities to create community football pitches that act as catalysts for sustainable social change; and

**WHEREAS**, since 2006, Love.fútbol has been able to lead projects in rural and urban communities throughout the Americas, Africa, Asia, and Oceania, currently reaching Eighty Thousand (80) youths per year; and

**WHEREAS**, the staff is requesting that the Mayor and City Council approve and authorize the execution of a Memorandum of Understanding (“MOU”), attached hereto as Exhibit 1, in partnership with Love.fútbol, at no cost to the City of North Miami (“City”), for the purpose of remodeling and installing a soccer mini-pitch system on one (1) of the basketball courts at Cagni Park South as well as a small grant to assist with programming the new space; and

**WHEREAS**, the Mayor and City Council recognize the value of such a program to the youth of this community and desire to enter into an MOU with Love.fútbol for the benefit of the residents of the City and to allow multi-sport use recreational opportunities to children and families in the City.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Approval.** The Mayor and City Council hereby approve this Memorandum of Understanding (“MOU”) between the City of North Miami (“City”) and Love.fútbol, Inc. (“Love.fútbol”), attached hereto as Exhibit 1.


**Section 2.**     **Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to execute an MOU between the City and Love.fútbol.

**Section 3.**     **Effective Date.** This Resolution will be effective immediately upon adoption.
