

**RESOLUTION NO. 2023-R-111**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER AND THE CITY  
ATTORNEY TO NEGOTIATE AND EXECUTE AN  
INTERLOCAL AGREEMENT BETWEEN THE CITY OF  
NORTH MIAMI AND THE NORTH MIAMI COMMUNITY  
REDEVELOPMENT AGENCY TO PROVIDE FOR NMCRA  
FUNDING IN THE AMOUNT OF TWO HUNDRED  
TWENTY-FIVE THOUSAND DOLLARS (\$225,000.00) TO  
BE USED TOWARDS THE COST OF THE DRIVEWAY  
APPROACH PROGRAM; FURTHER AUTHORIZING THE  
CITY MANAGER TO TAKE ALL ACTION NECESSARY TO  
IMPLEMENT THE TERMS OF THE INTERLOCAL  
AGREEMENT; PROVIDING FOR AN EFFECTIVE DATE  
AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (the “City”) is implementing a Driveway Approach Program to assist with the restoration and repair of driveway approaches throughout the City and North Miami Community Redevelopment Agency (“NMCRA”) Community Redevelopment Area for the benefit of City’s residents; and

**WHEREAS**, NMCRA Staff has recommended the approval of funding in the amount of Two Hundred Twenty-Five Thousand Dollars (\$225,000.00) for the Driveway Approach Program with such funding to be paid to the City by the NMCRA through an Interlocal Agreement; and

**WHEREAS**, Section 163.400, Florida Statutes, known as Cooperation by Public Bodies, encourages municipalities to do any and all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

**WHEREAS**, the Chair and Board Members of the NMCRA have approved the funding for the Driveway Approach Program and have authorized the Executive Director and NMCRA Attorney to negotiate, finalize, execute, and implement an Interlocal Agreement with the City for the funding of the Driveway Approach Program; and

**WHEREAS**, the Mayor and City Council desire to authorize the negotiation, finalization, and execution of an Interlocal Agreement with the City for these purposes.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an Interlocal Agreement with the North Miami Community Redevelopment Agency to provide for funding in the amount of Two Hundred Twenty-Five Thousand Dollars (\$225,000.00) to be used toward the cost of the Driveway Approach Program and further authorize the City Manager to take all action necessary to implement the terms of the Interlocal Agreement.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
