

**RESOLUTION NO. 2023-R-110**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING  
FISCAL YEAR 2023-2024 ANNUAL ACTION PLAN UNDER  
THE COMMUNITY DEVELOPMENT BLOCK GRANT  
(CDBG) AND HOME INVESTMENT PARTNERSHIPS  
PROGRAM (HOME) PROGRAMS; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) has been designated as an “Entitlement Community” and therefore receives direct annual funding from the U.S. Department of Housing and Urban Development (“HUD”) for Community Development Block Grant (“CDBG”) and Home Investment Partnerships Program (“HOME”) programs; and

**WHEREAS**, since 1994, the City has received CDBG funds from HUD to provide a source of funding for various community and economic development programs and projects; and

**WHEREAS**, since 2003, the City has received HOME funds to provide a source of funding for community housing programs in accordance with Chapter 420, Part V, Florida Statutes, as amended from time to time; and

**WHEREAS**, the City will receive Seven Hundred Eighty-Nine Thousand Three Hundred Sixty-Six Dollars and 00/100 Cents (**\$789,366.00**), and Three Hundred Fifty-Two Thousand Four Hundred Fifty-Eight Dollars and 00/100 Cents (**\$352,458.00**) in CDBG and HOME funds, respectively, for fiscal year (“FY”) 2023-2024 to fund various community and economic development programs and projects within the City; and

**WHEREAS**, HUD program regulations require that the City prepare an Annual Action Plan (“Action Plan”) for the use of grant funds with input from the public; and

**WHEREAS**, on April 20, 2023, the City conducted a duly noticed public meeting soliciting public views and input in the development of the Action Plan; and

**WHEREAS**, in accordance with HUD regulations, City administration prepared the FY 2023-2024 Action Plan for the use of CDBG and HOME funds; and

**WHEREAS**, on May 2, 2023, the Planning Commission, after a duly noticed public meeting, found the proposed Action Plan to be acceptable and beneficial to the City, and thereby recommended approval to the Mayor and City Council; and


**WHEREAS**, the Mayor and City Council, after a duly noticed public meeting, concur with the findings of the Planning Commission, and find the approval of the attached Action Plan will enhance the public's health, safety, and welfare.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA THAT:**

**Section 1. Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve Fiscal Year 2023-2024 Annual Action Plan under the Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) programs, attached hereto as "Exhibit A."


**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
