

RESOLUTION NO. 2023-R-127

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND MIAMI-DADE COUNTY TO PROVIDE FUNDING FROM THE MIAMI-DADE RESCUE PLAN FUND IN THE AMOUNT OF TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) TO BE USED TOWARDS THE EXPANSION OF THE NORTH MIAMI ALYSSA MACK-LIE LUCIEN SWIM PROGRAM; FURTHER AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTION NECESSARY TO IMPLEMENT THE TERMS OF THE INTERLOCAL AGREEMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on November 18, 2022, through Resolution No. 2022-R-192, the City of North Miami (“City”) developed the Alyssa Mack-Lie Learn to Swim Program to improve the water safety skills of its residents; and

WHEREAS, the Alyssa Mack-Lie Learn to Swim Program is an instructor-led swim lesson program, at the Thomas Sasso Pool, offered to youths and adults, with sessions offered year-round, eight (8) lessons per session, and classes lasting about 30-45 minutes long; and

WHEREAS, on September 20, 2022, the Board of County Commissioners of Miami-Dade, Florida, approved Ordinance No. 22-112, the Countywide General Fund Budget Ordinance, approving a Two Hundred Thousand Dollar (\$200,000.00) allocation to the City of North Miami from the Miami Rescue Plan (Continuation of County Services) for the North Miami Learn to Swim Program; and

WHEREAS, through the Miami-Dade County Miami-Dade Rescue Plan Fund, the Alyssa Mack-Lie Lucien Learn to Swim Program will expand to reach more residents of the City and residents of its surrounding areas and assist with drowning prevention where drowning is the second leading cause of death in children ages 5-14; and


WHEREAS, the Mayor and City Council desire to authorize the negotiation, finalization, and execution of an Interlocal Agreement with Miami-Dade County for these purposes.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an Interlocal Agreement with Miami-Dade County to provide for funding in the amount of Two Hundred Thousand Dollars (\$200,000.00) to be used toward the cost of expanding the Alyssa Mack-Lie Lucien Swim Program and further authorize the City Manager to take all action necessary to implement the terms of the Interlocal Agreement.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
