

RESOLUTION NO. 2023-R-125

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A CHANGE ORDER TO BASILE USA, LLC, IN THE AMOUNT OF TWO HUNDRED TWENTY-SEVEN THOUSAND THIRTY-ONE DOLLARS (\$227,031.00), TO PROVIDE ADDITIONAL SERVICES FOR THE WATER MAIN IMPROVEMENT PROJECT LOCATED ALONG N.E. 118 STREET FROM BISCAYNE CANAL ROAD TO WEST DIXIE HIGHWAY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on May 24, 2022, the City of North Miami (“City”) Mayor and City Council adopted Resolution No. 2022-R-71 approving Basile USA, LLC (“Basile”) to perform the Water Main Improvement Project located along N.E. 118 Street from Biscayne Canal Road to West Dixie Highway in accordance with Invitation for Bids No. 13-21-22 for a total project amount not exceeding Seven Hundred Sixty-Six Thousand Five Hundred Three Dollars (\$766,503.00); and

WHEREAS, Basile has submitted a change order for additional services needed for the completion of the project which has been reviewed and approved by City Staff as well as Kimley-Horn, the engineering consultant for the project; and

WHEREAS, City staff recommends approval of a change order to provide the additional services to ensure the completion of the Water Main Improvement Project; and

WHEREAS, the additional services needed for completion of the project will not exceed Two Hundred Twenty-Seven Thousand Thirty-One Dollars (\$227,031.00); and

WHEREAS, the Mayor and City Council find that the provision of additional services to ensure the completion of the project is in the best interest of the City and its residents and authorize the City Manager to issue a change order in support of this objective.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authorization to City Manager. The Mayor and City Council of the City of North Miami, Florida hereby authorize the City Manager to issue a change order to Basile USA,


LLC for an amount not-to-exceed Two Hundred Twenty-Seven Thousand Thirty-One Dollars (\$227,031.00) for the provision of additional body-worn camera video data storage services.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
