

**RESOLUTION NO. 2023-R-124**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO EXECUTE AN AMENDMENT TO THE ASPHALT PAVEMENT REPLACEMENT AGREEMENTS WITH METRO EXPRESS, INC., AND H&R PAVING, INC., TO EXTEND THE TERM OF THE AGREEMENTS AND INCLUDE ADDITIONAL SERVICES FOR THE CITY'S DRIVEWAY APPROACH PROGRAM AT A COST NOT TO EXCEED TWO HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$225,000.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, in May of 2020, the City of North Miami ("City") entered into agreements with H&R Paving, Inc. and Metro Express, Inc. ("Contractors") for the repair and replacement of asphalt rights-of-way throughout the City; and

**WHEREAS**, the City is desirous of implementing a Driveway Approach Program for resurfacing of driveway approaches throughout the City; and

**WHEREAS**, to accomplish this objective, City Staff recommends the execution of Amendments to the Asphalt Pavement Replacement agreements with Contractors to extend the term of the agreement for an additional one (1) year term and to include additional services related to the resurfacing of driveway approaches; and

**WHEREAS**, the proposed Amendments will extend the term of the agreement through May of 2024 and the cost for additional services will not exceed Two Hundred Twenty-Five Thousand Dollars (\$225,000.00); and

**WHEREAS**, the City administration respectfully requests that the Mayor and City Council authorize the execution of an amendment to the agreement authorizing the one (1) year extension to the term and the additional services related to the resurfacing of driveway approaches.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.**      **Authority to execute agreement.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to execute Amendments to the Asphalt Pavement Replacement Agreements with Metro Express, Inc. and H&R Paving, Inc., to extend the term of the agreement and to include additional services for the City's Driveway Approach Program at a cost not-to-exceed Two Hundred Twenty-Five Thousand Dollars (\$225,000.00).

**Section 2.**      **Effective Date.**      This Resolution shall be effective upon adoption.
