

**RESOLUTION NO. 2023-R-123**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER TO ISSUE  
PURCHASE ORDERS TO KOMPAN, INC., IN AN  
AGGREGATE AMOUNT NOT TO EXCEED TWO  
HUNDRED THOUSAND DOLLARS (\$200,000.00), FOR THE  
PURCHASE AND INSTALLATION OF PLAYGROUND  
EQUIPMENT FOR THE NORTH MIAMI LIBRARY TOT-  
LOT, UTILIZING THE COOPERATIVE PURCHASING  
PROVISION PURSUANT TO SEC. 7-169 OF THE CITY  
CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL  
OTHER PURPOSES.**

**WHEREAS**, City of North Miami (“City”) is desirous of upgrading the equipment and site conditions at the existing North Miami Library Tot-Lot located at 835 N.E. 132 Street; and

**WHEREAS**, City staff has received a quote from Kompan, Inc. (“Kompan”) utilizing Cooperative Purchasing Contract No. 2017001135 issued by OMNIA Partners; and

**WHEREAS**, Section 7-169 of the City Code authorizes the City to participate in cooperative purchasing agreements for the procurement of supplies or services with one (1) or more public entities; and

**WHEREAS**, in accordance with Section 7-169 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to issue purchase orders to Kompan for the purchase and installation of playground equipment for the North Miami Library Tot-Lot in an amount not to exceed Two Hundred Thousand Dollars (\$200,000.00), based on a competitive price to the City; and

**WHEREAS**, the Mayor and City Council find the cooperative purchase of playground equipment at a substantial savings is in the best interest of the City.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.    Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Kompan, Inc. in the aggregate amount not to exceed Two Hundred Thousand Dollars (\$200,000.00), utilizing the cooperative purchasing provision pursuant to Sec. 7-169 of the City Code.

**Section 2. Effective Date.** This Resolution shall be effective upon adoption.
