**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, RE-
APPOINTING JASON GILLIS TO GROUP C OF THE
PERSONNEL BOARD, TERM ENDING ON NOVEMBER 03,
2024, IN ACCORDANCE WITH CHAPTER 15, ARTICLE 1,
SECTION 15-4, OF THE CITY OF NORTH MIAMI CODE OF

WHEREAS, the Personnel Board shall consist of six (6) members who shall be a qualified voter of the city and shall be known to be in sympathy with the merit principle as applied to the civil service; and

WHEREAS, Councilman Scott Galvin desires to re-appoint Jason Gillis to Group C of the Personnel Board.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:
