

RESOLUTION NO. 2023-R-139

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE CITY MANAGER'S ISSUANCE OF PURCHASE ORDERS TO DUVAL FORD, IN THE AMOUNT OF ONE HUNDRED NINE THOUSAND TWO HUNDRED FORTY-FOUR DOLLARS AND FORTY CENTS (\$109,244.40), FOR THE PURCHASE OF FOUR (4) FORD MAVERICK VEHICLES FOR USE BY THE NEIGHBORHOOD SERVICES DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") Neighborhood Services Department is in need of new vehicles; and

WHEREAS, on June 20, 2023, the Mayor and City Council adopted Resolution No. 2023-R-103 authorizing the City Manager to take all action necessary to provide for the effective and efficient workings of city government to ensure that the City's best interests are protected during the recess period; and

WHEREAS, to ensure the purchase of vehicles within the very limited timeframe allotted by the manufacturer, the City Manager issued purchase orders in the amount of One Hundred Nine Thousand Two Hundred Forty-Four Dollars and Forty Cents (\$109,244.40) to Duval Ford for the purchase of four (4) Ford Maverick vehicles; and

WHEREAS, the vehicles were purchased utilizing Contract BCSO-22-27-1.0 issued by the Bradford County Sheriff's Office for the purchase of motor vehicles; and


WHEREAS, City administration respectfully requests that the Mayor and City Council ratify the issuance of the purchase orders.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the City Manager's issuance of Purchase Orders in the amount of One Hundred Nine Thousand Two Hundred Forty-Four Dollars and Forty Cents (\$109,244.40), to Duval Ford for the purchase of four (4) Ford Maverick vehicles for use by the Neighborhood Services Department.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
