

RESOLUTION NO. 2023-R-154

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND TETRA TECH, INC., FOR ENGINEERING CONSULTING SERVICES FOR THE “E” STATION FORCE MAIN AND GRAVITY SEWER PROJECT, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED EIGHTY THOUSAND TWENTY-EIGHT DOLLARS (\$380,028.00), PURSUANT TO REQUEST FOR QUALIFICATIONS #08-17-18 CONTINUING PROFESSIONAL ARCHITECTURAL & ENGINEERING SERVICES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on December 7, 2017, the City of North Miami (“City”) advertised *Request for Qualifications #08-17-18, Continuing Professional Architectural & Engineering Services* (“RFQ”), for the purpose of retaining a pool of experienced, licensed and insured architectural and engineering firms to provide on a continuing as-needed, when needed basis, the following specific services: Architecture, Landscape Architecture, Civil Engineering, Planning and Urban Design, Roadway, Traffic and Transportation Engineering and Consulting, Water/Waste Water Engineering, Water Resources and Stormwater Design and Environmental Engineering (“Services”); and

WHEREAS, the RFQ was undertaken in accordance with Florida’s Consultants’ Competitive Negotiation Act, under Section 287.055, Florida Statutes; and

WHEREAS, in response to the RFQ, Tetra Tech, Inc. (“Consultant”) submitted its qualifications for the provision of Water Resources and Stormwater Design Services and was approved to be included on the City’s list of pre-qualified firms pursuant to Resolution No. 2019-R-15; and

WHEREAS, as a part of the City administration’s commitment to improve the City’s existing infrastructure, City staff has secured a proposal from the Consultant to provide engineering services including design, permitting, bidding assistance and construction administration for the “E” Station Force Main and Gravity Sewer Improvement Project; and

WHEREAS, the project scope includes a proposed 10-inch gravity sewer along N.E. 10th Avenue, between N.E. 140th Street and N.E. 143rd Street and upsizing the existing 10-inch force

main from outside of “E” Station, along N.E. 143rd Street to N.E. 9th Avenue, south to N.E. 142nd Street, then west to the existing manhole discharge, just west of N.E. 9th Avenue; and

WHEREAS, Consultant has agreed to provide service services for a total fee not to exceed Three Hundred Eighty Thousand Twenty-Eight Dollars (\$380,028.00); and


WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the City Manager and City Attorney to negotiate and execute an agreement with Consultant for the provision of Services, relating to the “E” Station Force Main and Gravity Sewer Improvement Project.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:


Section 1. **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement between the City of North Miami and Tetra Tech, Inc., for the “E” Station Force Main and Gravity Sewer Improvement Project, at a cost not to exceed Three Hundred Eighty Thousand Twenty-Eight Dollars (\$380,028.00).

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
