

RESOLUTION NO. 2023-R-144

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE AWARD OF A CITY-ISSUED
FIREARM TO RETIRED POLICE OFFICER
DAGOBERTO ANDOLLO IN RECOGNITION OF
TWENTY-FOUR (24) YEARS OF SERVICE TO THE
CITY OF NORTH MIAMI AND NORTH MIAMI POLICE
DEPARTMENT; PROVIDING FOR AN EFFECTIVE
DATE AND ALL OTHER PURPOSES.**

WHEREAS, Dagoberto Andollo was a Police Officer with the City of North Miami Police Department, who retired on July 1, 2023, with twenty-four (24) years of service as a sworn law enforcement officer; and

WHEREAS, Retired Police Officer Andollo was assigned a service firearm that he utilized during his career as a law enforcement officer with the North Miami Police Department; and

WHEREAS, Retired Police Officer Andollo has met Florida Department of Law Enforcement ("FDLE") qualification standards with said firearm; and

WHEREAS, FDLE allows retired law enforcement officers to carry concealed firearms as it promotes public safety in the state and local municipalities; and

WHEREAS, Police Officer Andollo retired in good standing and wishes to retain possession of his city-issued firearm (Glock 40 Cal Model 22, serial number NHR830) effective on the date of retirement, July 1, 2023; and

WHEREAS, the City of North Miami has no further use of the described firearm and wishes to award retiring Police Officer Andollo with the firearm in recognition of his service to the City of North Miami and as an encouragement to other law enforcement officers to have long-term employment in the Department.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority to Award. The Police Chief, by and through the City Manager, is authorized to award to Police Officer Andollo, upon his retirement, his city-issued firearm in


recognition of his twenty-four (24) years of distinguished service to the City of North Miami and the North Miami Police Department.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
