

**RESOLUTION NO. 2023-R-142**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE AWARD OF A CITY-ISSUED  
FIREARM TO RETIRED POLICE OFFICER KRISTEN  
SCHUMANN IN RECOGNITION OF TWENTY-SIX (26)  
YEARS OF SERVICE TO THE CITY OF NORTH MIAMI  
AND NORTH MIAMI POLICE DEPARTMENT;  
PROVIDING FOR AN EFFECTIVE DATE AND ALL  
OTHER PURPOSES.**

**WHEREAS**, Kristen Schumann was a Police Officer with the City of North Miami Police Department, who retired on June 1, 2023, with twenty-six (26) years of service as a sworn law enforcement officer; and

**WHEREAS**, Retired Police Officer Schumann was assigned a service firearm that she utilized during her career as a law enforcement officer with the North Miami Police Department; and

**WHEREAS**, Retired Police Officer Schumann has met Florida Department of Law Enforcement (“FDLE”) qualification standards with said firearm; and

**WHEREAS**, FDLE allows retired law enforcement officers to carry concealed firearms as it promotes public safety in the state and local municipalities; and

**WHEREAS**, Police Officer Schumann retired in good standing and wishes to retain possession of her city-issued firearm (Sig Sauer P320, serial number 58C096159) effective on the date of retirement, June 1, 2023; and

**WHEREAS**, the City of North Miami has no further use of the described firearm and wishes to award retiring Police Officer Schumann with the firearm in recognition of her service to the City of North Miami and as an encouragement to other law enforcement officers to have long-term employment in the Department.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Authority to Award.** The Police Chief, by and through the City Manager, is authorized to award to Police Officer Schumann, upon her retirement, her city-issued firearm in

recognition of her twenty-six (26) years of distinguished service to the City of North Miami and the North Miami Police Department.

**Section 2.      Effective Date.** This Resolution shall become effective immediately upon adoption.
