

**RESOLUTION NO. 2023-R-161**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE CITY MANAGER'S EXECUTION OF THE NORTH MIAMI BREWFEST PARTNERSHIP AGREEMENT FOR SPONSORSHIP AND NAMING RIGHTS BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA INTERNATIONAL UNIVERSITY BOARD OF TRUSTEES; AUTHORIZING THE CITY MANAGER TO DO ALL THINGS NECESSARY TO IMPLEMENT THE PARTNERSHIP AGREEMENT ON BEHALF OF THE CITY; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on June 20, 2023, the Mayor and City Council of the City of North Miami (the "City") passed and adopted Resolution No. 2023-R-103, authorizing the City Manager, City Attorney, and City Clerk to take all necessary action and to execute all documents affecting the health, safety, and welfare of the City during the City Council's recess commencing July 12, 2023, through August 21, 2023; and

**WHEREAS**, in accordance with Resolution No. 2023-R-103, authority was delegated to the City Manager, to approve items during the summer recess under the condition that any items requiring Council approval would be subject to ratification at a subsequent council meeting; and

**WHEREAS**, on July 13, 2023, the City entered into a Sponsorship and Naming Rights Agreement with the Florida International University Board of Trustees ("FIU"), to provide for the City's sponsorship as a Title Partner of the 2023 North Miami BrewFest, which will be held on Saturday, November 4, 2023; and

**WHEREAS**, the City's partnership with FIU, as a Title Partner of the 2023 North Miami BrewFest, requires a cash contribution in the amount of One Hundred Twenty-Five Thousand Dollars (\$125,000.00) as well as in-kind contributions; and


**WHEREAS**, the Mayor and City Council have determined it is in the best interest of the City and its residents to ratify the execution of the Sponsorship and Naming Rights Agreement with FIU and deem it approved by the City Council.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Ratification.** The Mayor and City Council of the City of North Miami, Florida, hereby ratify the City Manager's execution of the 2023 North Miami BrewFest Partnership Agreement between the City of North Miami and the Florida International University Board of Trustees.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
