

RESOLUTION NO. 2023-R-164

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE CITY MANAGER TO EXECUTE SUB-
RECIPIENT AGREEMENT BETWEEN THE CITY OF
NORTH MIAMI AND THE POLICE ATHLETIC LEAGUE
OF NORTH MIAMI, INC., TO FUND YOUTH VIOLENCE
PREVENTION SERVICES PROGRAMS; PROVIDING AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, The Police Athletic League of North Miami, Inc., (“NMPAL”) was awarded a grant from the United States Department of Justice’s (“USDOJ”) Bureau of Justice Assistance (“BJA”) Students, Teachers, and Officers Preventing (“STOP”) School Violence Act of 2018 Program pursuant to its federally funded subaward with PALs of South Florida, Inc.; and

WHEREAS, the City of North Miami (the “City”) and NMPAL are desirous of entering into a sub-recipient agreement to provide youth violence prevention services in accordance with the grant requirements at various school sites within the city; and

WHEREAS, the federal funds were appropriated to address training and increasing students, school staff, and community member’s knowledge of school violence and aversion tactics as well as providing access to mental health and wellness coping strategies and services for the students; and

WHEREAS, the Mayor and City Council find it in the best interest of the City and its residents to fully authorize the negotiation and execution of the sub-recipient agreement between the City and the NMPAL.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY

Section 1. Approval of Sub-recipient Agreement. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the sub-recipient agreement between the City of North Miami and The Police Athletic League of North Miami, Inc.

Section 2. Authority of City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute a sub-recipient agreement between the City of North Miami and The Police Athletic League of North Miami, Inc.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
