

RESOLUTION NO. 2023-R-167

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE UNITED STATES DEPARTMENT OF JUSTICE TO SECURE A GRANT FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (the “City”) submitted an application for a grant from the United States Department of Justice’s (“USDOJ”) Edward Byrne Memorial Justice Assistance Grant (“JAG”) Program; and

WHEREAS, the City requested a grant in the amount of Forty-Six Thousand Five Hundred Forty-Three Dollars and Zero Cents (\$46,543.00), with no required match from the City; and

WHEREAS, the grant funds will be utilized to enhance the North Miami Police Department’s (“NMPD”) Records Management System (“RMS”) program software to interface with the State of Florida’s data collection and reporting software, TraCS (Traffic and Criminal Software); and

WHEREAS, an interface between NMPD’s RMS and TraCS will increase efficiency and result in a substantial reduction of potential errors, while meeting the State of Florida’s reporting requirements; and

WHEREAS, the Mayor and City Council find it in the best interest of the City and its residents to ratify the submittal of the grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the USDOJ for the purpose of securing grant funds.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Submittal of Grant Application. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submittal of the City of North Miami's application for a grant from the United States Department of Justice's Edward Byrne Memorial Justice Assistance Grant Program.

Section 2. Authority of City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami and the United States Department of Justice.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
