

RESOLUTION NO. 2023-R-168

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
RATIFYING THE SUBMITTAL OF A GRANT
APPLICATION AND AUTHORIZING THE CITY
MANAGER AND CITY ATTORNEY TO NEGOTIATE AND
EXECUTE AN AGREEMENT BETWEEN THE CITY OF
NORTH MIAMI AND THE STATE OF FLORIDA OFFICE
OF THE ATTORNEY GENERAL TO SECURE A GRANT
FROM THE VICTIMS OF CRIME ACT (VOCA)
ASSISTANCE GRANTS PROGRAM; PROVIDING FOR AN
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (the “City”) submitted an application for a grant from the State of Florida Office of the Attorney General’s (“OAG”) Victims of Crime Act (VOCA) Assistance Grants Program; and

WHEREAS, the City requested a grant in the amount of One Hundred Twenty-Four Thousand Seven Hundred Eight Dollars and Zero Cents (\$124,708.00), with no required match from the City; and

WHEREAS, the grant funds will be utilized to fund the North Miami Police Department’s Crisis Intervention Specialist in providing crisis intervention for victims of violent crimes and responding to the emotional and physical needs of victims of domestic violence; and

WHEREAS, the Mayor and City Council find it in the best interest of the City and its residents to ratify the submittal of the grant application as well as to fully authorize the negotiation and execution of an agreement between the City and the OAG for the purpose of securing grant funds.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification of Submittal of Grant Application. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the submittal of the City of North Miami’s application for a grant from the State of Florida Office of the Attorney General’s Victims of Crime Act (VOCA) Assistance Grants Program.

Section 2. Authority of City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami and the State of Florida Office of the Attorney General.


Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
