

**RESOLUTION NO. 2023-R-174**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE EXECUTION OF A FOOD SUPPLY  
SERVICES AGREEMENT, IN SUBSTANTIALLY THE  
ATTACHED FORM, BETWEEN THE CITY OF NORTH  
MIAMI AND VICTORY FOR YOUTH, INC., D/B/A SHARE  
YOUR HEART TO PROVIDE AND DELIVER FOOD  
SUPPLY AND FACILITATE SERVICES TO THE NOMI  
FOOD PANTRY IN THE AMOUNT OF TEN THOUSAND  
DOLLARS (\$10,000.00) PER MONTH, NOT-TO-EXCEED A  
TOTAL ANNUAL COMPENSATION OF ONE HUNDRED  
TWENTY THOUSAND DOLLARS AND 00/100 CENTS  
(\$120,000.00); PROVIDING FOR AN EFFECTIVE DATE  
AND ALL OTHER PURPOSES.**

**WHEREAS**, on February 23, 2021, the City of North Miami (the “City”) formed the NOMI Food Pantry, Inc., a Florida non-profit organization under section 501(c)(3) of the Internal Revenue Code; and

**WHEREAS**, the organization’s formation was to make possible the solicitation and acceptance of financial contributions in order to achieve the goal of providing assistance and addressing the continued demand for food security for those residents who are unable to afford food and groceries due to their economic status; and

**WHEREAS**, the City desires to continue to support its mission of providing North Miami residents with access to a fully stocked community food pantry to ensure that residents are not left struggling with food insecurity due to financial constraints; and

**WHEREAS**, the City and Victory for Youth, Inc., d/b/a Share Your Heart (“Share Your Heart”) are desirous of entering into a Food Supply Services Agreement for the purpose of establishing a mutual framework of food services provided to the NOMI Food Pantry; and

**WHEREAS**, Share Your Heart will provide and deliver on a bi-monthly basis six hundred (600) household bags, of approximately eleven (11) pounds each, of non-perishable food; and

**WHEREAS**, Share Your Heart, for its services, will be compensated Ten Thousand Dollars (\$10,000.00) per month, not to exceed a total annual compensation of One Hundred Twenty Thousand Dollars (\$120,000.00); and

**WHEREAS**, the Mayor and City Council believe that an Agreement for this purpose will benefit the residents of the City and should be entered into with Share Your Heart.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.     Approval of Agreement.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Food Supply Services Agreement between the City of North Miami and Share Your Heart, attached hereto as "Exhibit 1."

**Section 2.     Authority of City Manager.** The City Manager is authorized to execute the Food Supply Services Agreement with Share Your Heart, attached hereto as "Exhibit 1."

**Section 3.     Effective Date.** This Resolution shall become effective immediately upon adoption.
