

**RESOLUTION NO. 2023-R-175**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO REP SERVICES, INC., IN AN AGGREGATE AMOUNT NOT TO EXCEED FOUR HUNDRED TWENTY-NINE THOUSAND EIGHT HUNDRED EIGHTY-THREE DOLLARS (\$429,883.00), FOR THE PURCHASE AND INSTALLATION OF PLAYGROUND EQUIPMENT AND ARTIFICIAL TURF FOR BREEZESWEPT PARK PROJECT, UTILIZING THE CLAY COUNTY CONTRACT ISSUED PURSUANT TO RFP NO. 18/19-2, IN ACCORDANCE WITH SECTION 7-167 OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, City of North Miami (“City”) is desirous of upgrading the equipment and site conditions at the existing North Miami Breezeswept Park located at 12501 N.E. 2 Avenue; and

**WHEREAS**, City staff has identified a contract issued by Clay County to REP Services, Inc. (“REP”) for the purchase and installation of playground equipment and artificial turf at a discount for both the cost of equipment and the cost of installation; and

**WHEREAS**, in accordance with Section 7-167 of the City Code, the City administration may purchase supplies or services from current contracts of other governmental agencies, with City Council approval on any such purchase which exceeds Twenty-Five Thousand Dollars (\$25,000.00); and

**WHEREAS**, the City administration desires to utilize the Clay County contract awarded under RFP No. 18/19-2 to obtain competitive pricing; and

**WHEREAS**, in accordance with Section 7-167 of the City Code, the City administration respectfully requests that the Mayor and City Council authorize the City Manager to issue purchase orders to REP for the purchase and installation of playground equipment and artificial turf for the North Miami Breezeswept Park in an amount not to exceed Four Hundred Twenty-Nine Thousand Eight Hundred Eighty-Three Dollars (\$429,883.00), based on a competitive price to the City; and


**WHEREAS**, the Mayor and City Council find that the purchase and installation of playground equipment and artificial turf, in accordance with Section 7-167 of the City Code, is in the best interest of the City.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.**     **Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to REP Services, Inc. in the aggregate amount not to exceed Four Hundred Twenty-Nine Thousand Eight Hundred Eighty-Three Dollars (\$429,883.00), utilizing a contract awarded by the Clay County in response to Request for Proposals ("RFP") No. 18/19-2, pursuant to Section 7-167 of the North Miami Code of Ordinances.

**Section 2.**     **Effective Date.** This Resolution shall be effective upon adoption.
