

**RESOLUTION NO. 2023-R-192**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A CHANGE ORDER TO ENVISIONWARE, INC., IN THE AMOUNT OF EIGHTY-SEVEN THOUSAND FIVE HUNDRED FIFTY-THREE DOLLARS (\$87,553.00), TO PROVIDE ADDITIONAL SERVICES AND MATERIALS TO COMPLETE THE 24-HOUR SELF-SERVICE FULLY AUTOMATED LIBRARY KIOSK TO BE INSTALLED ADJACENT TO THE JOE CELESTIN CENTER; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on January 11, 2022, the City of North Miami (“City”) City Manager approved the purchase and installation of a 24-hour library kiosk, pursuant to the authority granted under Resolution 2021-R-81 to award and execute a contract not exceeding Two Hundred Fifty Thousand Dollars (\$250,000.00), for projects funded through the American Rescue Plan Act; and

**WHEREAS**, the initial proposal from EnvisionWare, Inc. (“EnvisionWare”) was for a standard unit designed to meet varying code requirements through the country; and

**WHEREAS**, due to Miami-Dade County’s stringent building code and wind threshold requirement, EnvisionWare was forced to re-design a new customized canopy in order to meet Miami-Dade County’s code requirements and to complement the existing design of the adjacent Joe Celestin Center; and

**WHEREAS**, EnvisionWare has submitted a change order for additional services needed for the completion of the project which will include the cost of custom materials to meet code requirements, heavier gauge steel materials, and the additional cost to re-design and provide structural engineering approvals for the custom designed canopy; and

**WHEREAS**, City staff recommends approval of a change order to provide the additional services to ensure completion of the 24-Hour Library Project; and

**WHEREAS**, the additional services needed for completion of the project will not exceed Eighty-Seven Thousand Five Hundred Fifty-Three Dollars (\$87,553.00); and

**WHEREAS**, the Mayor and City Council find that the provision of additional services and materials to ensure completion of the project is in the best interest of the City and its residents and authorize the City Manager to issue a change order in support of this objective.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authorization to City Manager.** The Mayor and City Council of the City of North Miami, Florida hereby authorize the City Manager to issue a change order to Envisionware, Inc. for an amount not to exceed Eighty-Seven Thousand Five Hundred Fifty-Three Dollars (\$87,553.00) for the provision of additional services and materials for the 24-hour Self-Service Fully Automated Library Kiosk to be installed at the Joe Celestin Center.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
