

**RESOLUTION NO. 2023-R-191**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH ESR, LLC IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SIX THOUSAND SIXTY-FIVE DOLLARS (\$106,065.00), FOR THE PURCHASE AND DELIVERY OF PRE-FILLED SANDBAGS, UTILIZING CITY OF MIAMI GARDENS ITB NO. 22-23-018, IN ACCORDANCE WITH SECTION 7-167 OF THE NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on April 11, 2023, the City of Miami Gardens issued ITB No. 22-23-018 soliciting bids from qualified and experienced vendors to establish a pool of term contractors for the emergency supply and delivery of pre-filled sandbags, on an as-needed basis; and

**WHEREAS**, in response to the solicitation, ESR, LLC submitted their proposal and was selected by the City of Miami Gardens to be included in the pool of contractors; and

**WHEREAS**, Section 7-167 of the City of North Miami ("City") Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods, and/or services from current agreements of other municipalities and governmental entities ("piggyback"), such as Miami Gardens; and

**WHEREAS**, the City administration desires to utilize the City of Miami Gardens contract awarded under ITB No. 22-23-018 to obtain competitive pricing; and

**WHEREAS**, City administration respectfully requests approval to utilize City of Miami Gardens ITB No. 22-23-018 for the negotiation and execution of an Agreement in an amount not to exceed One Hundred Six Thousand Sixty-Five Dollars (\$106,065.00) to provide the City with pre-filled sandbags; and


**WHEREAS**, the Mayor and City Council find that the purchase of pre-filled sandbags, in accordance with Section 7-167 of the City Code, is in the best interest of the City.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**     **Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with ESR, LLC, in an amount not to exceed One Hundred Six Thousand Sixty-Five Dollars (\$106,065.00) for the purchase and delivery of pre-filled sandbags, utilizing a contract awarded by the City of Miami Gardens in response to ITB No. 22-23-018, pursuant to Section 7-167 of the North Miami Code of Ordinances.

**Section 2.**     **Effective Date.** This Resolution shall become effective immediately upon adoption.
