

**RESOLUTION NO. 2023-R-180**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, REMOVING  
MICHAEL MCDEARMAID FROM THE CHARTER  
BOARD, AS APPOINTEE OF VICE MAYOR ESTIME-  
IRVIN AND RE-APPOINTING MICHAEL MCDEARMAID  
AS APPOINTEE OF MAYOR DESULME, IN  
ACCORDANCE WITH CHAPTER 2, ARTICLE 3, OF THE  
CITY OF NORTH MIAMI CODE OF ORDINANCES;  
PROVIDING FOR AN EFFECTIVE DATE AND ALL  
OTHER PURPOSES.**

**WHEREAS**, the Charter Board was created for the purpose of reviewing and analyzing the City Charter and recommending to the city council, for its consideration, amendments to the Charter as indicated in Section 2-81 of the City Code; and

**WHEREAS**, Chapter 2, Article 3, Section 2-82, of the City of North Miami Code of Ordinances, allows the Mayor and each Councilmember to appoint one (1) member to the Charter Board and two (2) additional members of the charter board shall be appointed by the city council as a whole; and

**WHEREAS**, Charter Board members may be removed by a majority of the city council, as specified in Section 2-82 of the City Code; and

**WHEREAS**, the Mayor and Council find that it is in the best interest and welfare of the City of North Miami to remove Charter Board Member Michael McDearmaid as an appointee of Vice-Mayor Estime-Irvin and re-appoint him as Mayor Desulme's appointee.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**


**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Removal.** The Mayor and City Council of the City of North Miami, Florida, hereby remove Michael McDearmaid from the Charter Board as the appointee of Vice-Mayor Estime-Irvin.

**Section 3. Re-Appointment.** The Mayor and City Council of the City of North Miami, Florida, hereby appoint Michael McDearmaid as the appointee of Mayor Desulme.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon adoption.
