

**RESOLUTION NO. 2023-R-212**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER AND CITY  
ATTORNEY TO NEGOTIATE AND EXECUTE AN  
AGREEMENT WITH M.T. CAUSLEY, LLC FOR THE  
PROVISION OF SUPPLEMENTAL BUILDING  
INSPECTION AND PLAN REVIEW SERVICES, ON AN AS-  
NEEDED BASIS, IN AN AMOUNT NOT TO EXCEED FOUR  
HUNDRED THOUSAND DOLLARS (\$400,000.00),  
UTILIZING CITY OF DORAL CONTRACT NO. 2023-04, IN  
ACCORDANCE WITH SECTION 7-167 OF THE NORTH  
MIAMI CODE OF ORDINANCES; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on May 5, 2023, the City of Doral issued RFQ No. 2023-04 – Building Inspection and Plans Review Services, seeking supplemental building inspection and plan review services, on an as-needed basis; and

**WHEREAS**, in response to the solicitation, M.T. Causley, LLC was selected, and the City of Doral entered into a Contract with an initial term ending August 30, 2026; and

**WHEREAS**, Section 7-167 of the City of North Miami (“City”) Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods, and/or services from current agreements of other municipalities and governmental entities (“piggyback”), such as the City of Doral; and

**WHEREAS**, the City administration desires to utilize the City of Doral contract awarded under RFQ No. 2023-04 to obtain competitive pricing; and

**WHEREAS**, City administration respectfully requests approval to utilize City of Doral Contract No. 2023-04 for the negotiation and execution of an Agreement in an amount not to exceed Four Hundred Thousand (\$400,000.00) to provide the City with supplemental building inspection and plan review services; and

**WHEREAS**, the Mayor and City Council find that the provision of inspection services, in accordance with Section 7-167 of the City Code, is in the best interest of the City.

**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with M.T. Causley, LLC, in an amount not to exceed Four Hundred Thousand (\$400,000.00) for the provision of supplemental building inspection and plan review services, on an as-needed basis, utilizing a contract awarded by the City of Doral in response to RFQ No. 2023-04, pursuant to Section 7-167 of the North Miami Code of Ordinances.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
