**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE CITY MANAGER AND CITY
ATTORNEY TO NEGOTIATE AND EXECUTE AN
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI
AND GOVERNMENT & ERP IMPLEMENTATION
SERVICES, LLC TO PROVIDE THE CITY WITH
ENTERPRISE RESOURCE PLANNING (ERP) SOFTWARE
IMPLEMENTATION AND PROJECT MANAGEMENT
CONSULTING SERVICES, ON AN AS NEEDED BASIS,
FOR AN AMOUNT NOT EXCEEDING ONE HUNDRED
SEVENTY-FIVE THOUSAND DOLLARS (\$175,000.00);
WAIVING COMPETITIVE BIDDING IN ACCORDANCE
WITH SECTION 7-120(B) OF THE NORTH MIAMI CODE
OF ORDINANCES; PROVIDING FOR AN EFFECTIVE
DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami (“City”) is in the process of transitioning from the current Tyler EDEN ERP Software System to Tyler’s next-generation Munis ERP and Energov Software Suite; and

WHEREAS, in order to facilitate the conversion of data and to help minimize disruptions during the deployment of the new ERP system, City staff requested a proposal for implementation and project management services; and

WHEREAS, Government & ERP Implementation Services, LLC (“Contractor”) will provide services including, but not limited to, project management, analysis and design, testing and conversions, report design and creation, procedure guides and city-wide training and support; and

WHEREAS, services will be provided for a cost not exceeding One Hundred Seventy-Five Thousand Dollars (\$175,000.00); and

WHEREAS, the Mayor and City Council have determined that the execution of an Agreement to provide for ERP implementation and project management services is in the best interest of the City and should be entered into.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. Waiver. The Mayor and City Council of the City of North Miami, Florida, hereby waive competitive bidding procedures in accordance with Section 7-120(b) of the Procurement Code.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an Agreement between the City of North Miami and Government & ERP Implementation Services, LLC for ERP implementation and project management services at a cost not to exceed One Hundred Seventy-Five Thousand Dollars (\$175,000.00).

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
