

**RESOLUTION NO. 2023-R-206**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF  
THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE  
AWARD OF FISCAL YEAR 2023-2024 COMMUNITY  
DEVELOPMENT BLOCK GRANT FUNDS TO NOT-FOR-  
PROFIT COMMUNITY-BASED ORGANIZATIONS AS  
REQUIRED BY 24 CFR 570.201(E); PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) was awarded U.S. Department of Housing and Urban Development Community Development Block Grant (“CDBG”) funds in Fiscal Year 2023-2024 to provide funding for various community and economic development programs and projects; and

**WHEREAS**, since 1999, the City has awarded CDBG funds to not-for-profit community-based organizations (“CBO”) to provide local social services to the City’s at-risk population; and

**WHEREAS**, on June 27, 2023, the Mayor and City Council approved the City’s Fiscal Year 2023-2024 Annual Action Plan wherein CDBG funds in the amount of Ninety Thousand Dollars (\$90,000.00), were set aside for not-for-profit CBOs’ social services activities; and

**WHEREAS**, from July 2 through July 3, 2023, the City advertised a Request for Proposals seeking CBOs capable of delivering various social services to North Miami residents and meeting at least one of the CDBG National Objectives of benefitting low- and moderate-income persons, preventing or eliminating slums or blight and/or meeting an urgent need as well as meeting the City’s public services priorities of youth services, senior services, and/or young adult services; and

**WHEREAS**, at the closing of the application period, the City received seven (7) applications; all seven (7) proposals were evaluated by the CBO Advisory Panel (“Panel”) and the scores are attached as Exhibit “A”; and

**WHEREAS**, all seven (7) CBOs were found to be qualified with proposals that met both CDBG National Objectives and City’s Public Services Priorities attached as Exhibit “B” and were awarded funding for the upcoming fiscal year by the Panel; and

**WHEREAS**, on October 3, 2023, the Planning Commission, after a duly noticed public hearing reviewed the CBOs’ proposals and found the award recommendations of the Panel to be

acceptable and beneficial to the City, and thereby recommended approval to the Mayor and City Council; and

**WHEREAS**, the Mayor and City Council of the City of North Miami find that the services provided by the qualified CBOs serve the best interests of the City and its residents and are desirous of approving the award of CDBG funds to the qualified CBOs.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approval of Award.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the award of Fiscal Year 2023-2024 Community Development Block Grant funds to not-for-profit Community-Based Organizations.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
