

RESOLUTION NO. 2023-R-205

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE AN INTERLOCAL SERVICES AGREEMENT, IN SUBSTANTIALLY THE ATTACHED FORM, BETWEEN THE CITY OF NORTH MIAMI AND THE NORTH MIAMI COMMUNITY REDEVELOPMENT AGENCY FOR THE PROVISION OF INDIRECT SERVICES BY THE CITY TO THE NMCRA FOR FISCAL YEAR 2023-2024; FURTHER AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE TERMS AND CONDITIONS OF THE INTERLOCAL SERVICES AGREEMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the North Miami Community Development Agency (“NMCRA”) desires that the City of North Miami (“City”), provide certain indirect services to the NMCRA for Fiscal Year 2023-2024; and

WHEREAS, Section 163.400 of the Florida Statutes encourages municipalities to do any all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

WHEREAS, the Mayor and City Council desires to approve the Interlocal Services Agreement relating to the provision of indirect services by the City to the NMCRA, in substantially the form attached as Exhibit “A.”

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The City Manager is authorized to execute an Interlocal Services Agreement, in substantially the attached form, between the City of North Miami and the North Miami Community Redevelopment Agency for the provision of indirect services by the City to the NMCRA for Fiscal Year 2023-2024.

Section 2. Implementation of Interlocal Service Agreement. The City Manager is hereby authorized to take all actions necessary to implement the terms and conditions of the Interlocal Services Agreement.

Section 3. **Effective Date.** This Resolution shall be effective immediately upon approval.
