

RESOLUTION NO. 2023-R-204

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING
THE GUIDELINES ATTACHED AS EXHIBIT "A"
PROVIDING FOR THE ALLOCATION OF FUNDS TO
COMMUNITY-BASED ORGANIZATIONS FROM THE
GENERAL FUND; PROVIDING FOR AN EFFECTIVE
DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami ("City"), as part of its budgetary process, provides for allocations of funds to be used toward community-based organizations ("CBO"); and

WHEREAS, there is currently no established procedure for the award of these grants deriving from the City's general fund; and

WHEREAS, if the Mayor and Council wish to allocate funding from the General Funds to additional community-based organizations, a call for proposals must be issued following an application process to be approved by the Mayor and Council.

WHEREAS, to ensure consistency and efficiency in the budgetary process, City administration recommends the adoption of the attached Guidelines for the Allocation of Funds to Community-Based Organizations ("Guidelines"), to establish a detailed policy and procedure for all grant allocations coming from the general fund; and

WHEREAS, the Mayor and City Council are desirous of adopting the attached Guidelines to ensure consistency in the CBO grant award process.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. Amendment to the Housing Program Guidelines. The Mayor and City Council of the City of North Miami hereby approve and adopt the Guidelines for the Allocation of Funds to Community-Based Organizations from the General Fund, attached hereto as Exhibit "A".

Section 2. Effective Date. This Resolution shall be effective immediately upon adoption.
