

RESOLUTION NO. 2023-R-225

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY AND NUE URBAN CONCEPTS, LLC, IN AN AMOUNT NOT TO EXCEED NINETY-TWO THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$92,750.00), FOR THE DEVELOPMENT OF A CITYWIDE MOBILITY PLAN; WAIVING COMPETITIVE BIDDING IN ACCORDANCE WITH SECTION 7-120(B) OF THE NORTH MIAMI CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) is desirous of developing a Citywide mobility plan and associated mobility fee schedule as part of the City Administration’s ongoing effort to evaluate and improve the City’s current transportation needs and prepare for projected future growth impacts; and

WHEREAS, City staff has received a proposal from NUE Urban Concepts, LLC (“Consultant”) to develop a Citywide mobility plan and proposed mobility fee schedule which will include recommended multimodal quality of service standards, street quality of service standards based on posted speed limits to replace roadway level of service; and

WHEREAS, additionally, the mobility plan will provide: (1) a mixture of multimodal corridors, based on prior planning studies and current mobility trends for arterials and collectors; (2) transit circulators based on current transit plans and mobility trends; and (3) the establishment of programs for local city streets such as neighborhood traffic calming and streetscape enhancements; and

WHEREAS, Consultant will provide the services for an amount not to exceed Ninety-Two Thousand Seven Hundred Fifty Dollars (\$92,750.00); and

WHEREAS, in accordance with Section 7-120(b) of the City of North Miami’s Code of Ordinances, the Mayor and City Council may waive any condition imposed by the provisions of the Procurement Code upon a four-fifths vote when it finds such a waiver to be necessary in order to proceed with the issuance of a contract, proposal or bid which is in the best interest of the City; and

WHEREAS, City staff is requesting authorization of a waiver of competitive bidding procedures by the Mayor and City Council, in accordance with Section 7-120(b) of the Procurement Code, and further authorization for the City Manager and City Attorney to negotiate and execute an agreement with the selected consultant; and

WHEREAS, the Mayor and City Council desire to waive competitive bidding procedures in accordance with Section 7-120(b) of the Procurement Code, and to authorize the City Manager and City Attorney to negotiate and execute an agreement with the selected consultant.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Waiver. The Mayor and City Council of the City of North Miami, Florida, hereby waive competitive bidding procedures in accordance with Section 7-120(b) of the Procurement Code.

Section 2. Authorization to the City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida hereby authorize the City Manager and City Attorney to negotiate and execute a Professional Services Agreement with NUE Urban Concepts, LLC to develop a Citywide Mobility Plan, in an amount not to exceed Ninety-Two Thousand Seven Hundred Fifty Dollars (\$92,750.00).

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
