**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE CITY MANAGER AND CITY
ATTORNEY TO NEGOTIATE AND EXECUTE A
PURCHASE AGREEMENT BETWEEN THE CITY OF
NORTH MIAMI AND PETERSON'S HARLEY-DAVIDSON
OF MIAMI, LLC FOR THE PURCHASE OF EIGHT (8) 2023
FLHP POLICE MOTORCYCLES TO BE UTILIZED BY THE
NORTH MIAMI POLICE DEPARTMENT'S
MOTORCYCLE UNIT, FOR AN AMOUNT NOT
EXCEEDING TWO HUNDRED FORTY-NINE THOUSAND
DOLLARS (\$249,000.00); WAIVING COMPETITIVE
BIDDING IN ACCORDANCE WITH SECTION 7-120(B) OF
THE NORTH MIAMI CODE OF ORDINANCES;
PROVIDING FOR AN EFFECTIVE DATE AND ALL
OTHER PURPOSES.**

WHEREAS, the City of North Miami ("City") is desirous of purchasing eight (8) new motorcycles to be used by the North Miami Police Department ("NMPD") motorcycle unit; and

WHEREAS, the NMPD's motorcycle patrol unit is tasked with daily traffic details and for participation in numerous special events; and

WHEREAS, the ensure the NMPD's traffic safety unit is able to effectively carry out its duties related to traffic control and enforcement throughout the City, staff recommends the purchase of eight (8) additional motorcycles to augment the existing fleet and enhance the operations of the department; and

WHEREAS, Peterson's Harley-Davidson of Miami, LLC ("Contractor") has provided a quote for eight (8) new motorcycles which will not exceed the cost of Two Hundred Forty-Nine Thousand Dollars (\$249,000.00); and

WHEREAS, the Mayor and City Council have determined that the execution of a Purchase Agreement for the purchase of eight (8) motorcycles for the NMPD motors unit is in the best interest of the City and should be entered into.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. Waiver. The Mayor and City Council of the City of North Miami, Florida, hereby waive competitive bidding procedures in accordance with Section 7-120(b) of the Procurement Code.

Section 2. Authority of City Manager and City Attorney. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute a Purchase Agreement between the City of North Miami and Peterson's Harley-Davidson of Miami, LLC for the purchase of Eight (8) 2023 FLHP Police Motorcycles to be used by the North Miami Police Department's motorcycle unit at a cost not to exceed Two Hundred Forty-Nine Thousand Dollars (\$249,000.00).

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
