

**RESOLUTION NO. 2023-R-230**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, TO SECURE A FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM GRANT IN SUPPORT OF IMPROVEMENTS AT THE ROTARY OVERBROOK TOT-LOT AT ALHAMBRA HEIGHTS; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.**

**WHEREAS**, the Mayor and City Council are desirous of securing a grant from the Florida Division of Emergency Management; and

**WHEREAS**, the City of North Miami (“City”) is requesting a grant in the amount of One Hundred Twenty Thousand Dollars and No Cents (\$120,000.00) with a 20% required match in the amount of Thirty Thousand Dollars (\$30,000.00) for a total project cost in the amount of One Hundred Fifty Thousand Dollars and No Cents (\$150,000.00); and

**WHEREAS**, funds will be used toward rehabilitation and improvements of the Rotary Overbrook Tot-Lot at Alhambra Heights; and

**WHEREAS**, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the Florida Department of Environmental Protection.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:**


**Section 1. Ratification of Submittal of Application.** The Mayor and City Council hereby ratify the submittal of the City of North Miami’s application for a grant from the Florida Division of Environmental Protection in support of a Florida Recreation Development Assistance Grant.

**Section 2. Authority to City Manager and City Attorney.** The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of

North Miami, Florida, and the Florida Department of Environmental Protection to obtain grant funds.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
