

RESOLUTION NO. 2023-R-229

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE SUBMITTAL OF A GRANT APPLICATION AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE AMERICAN BEVERAGE FOUNDATION FOR A HEALTHY AMERICA AND THE AFRICAN AMERICAN MAYORS ASSOCIATION, TO SECURE THE NUTRITION ACCESS, AFFORDABILITY, AND EDUCATION GRANT IN SUPPORT OF THE NOMI FOOD PANTRY; PROVIDING FOR AN EFFECTIVE DATE, AND ALL OTHER PURPOSES.

WHEREAS, the Mayor and City Council are desirous of securing a grant from the American Beverage Foundation for a Healthy America and the African American Mayors Association; and

WHEREAS, the City of North Miami (“City”) requested a grant in the amount of Seventy-Five Thousand Dollars and No Cents (\$75,000.00) with no required match; and

WHEREAS, funds will be used to enhance the NoMi Food Pantry's capacity to provide essential food resources to residents in need and secure a monthly rental of a refrigeration truck to facilitate increased deliveries of fresh produce throughout the community; and

WHEREAS, the Mayor and City Council wish to ratify the submittal of a grant application as well as to fully authorize the negotiation and execution of an agreement for grant funds between the City and the American Beverage Foundation for a Healthy America and the African American Mayors Association.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Ratification of Submittal of Application. The Mayor and City Council hereby ratify the submittal of the City of North Miami's application for a grant from the American Beverage Foundation for a Healthy America and the African American Mayors Association in support of the NoMi Food Pantry.

Section 2. Authority to City Manager and City Attorney. The City Manager and City Attorney are hereby authorized to negotiate and execute an agreement between the City of North Miami, Florida and the American Beverage Foundation for a Healthy America and the African American Mayors Association to obtain grant funds.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
