

**RESOLUTION NO. 2024-R-4**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, SETTING THE RUNOFF ELECTION DATE FOR THE 2024 GENERAL ELECTION FOR THE DATE OF TUESDAY, DECEMBER 3, 2024, AS REQUESTED BY THE MIAMI-DADE COUNTY ELECTIONS DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on November 28, 2023, the Mayor and City Council adopted Resolution No. 2023-R-218 calling for the election of the Mayor, two (2) Councilmembers, and the City Clerk, with the election to be held on November 5, 2024, with any necessary runoff election to be held on November 26, 2024, pursuant to the City Charter and Code of Ordinance provisions; and

**WHEREAS**, the Miami-Dade County Elections Department has advised that the November 26, 2024, runoff election date is unavailable as the Department requires a specific post-General Election timeline to conduct potential statewide, county, or municipal recount(s), certify election results as well as post-election audit functions/reports as mandated by Florida Statutes; and

**WHEREAS**, the earliest date available for conducting the runoff election has been identified as December 3, 2024, which would give voters approximately 20 to 27 days to return their ballots inclusive of the federal holiday; and

**WHEREAS**, the Mayor and City Council find that it is in the best interest of the City to change the runoff election date in accordance with the request made by the Miami-Dade County Supervisor of Elections.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Election and Run-Off Dates.** An election will be called on November 5, 2024, for the purpose of electing the Mayor, a Councilmember for District No. 1, a Councilmember for District No. 4, and the City Clerk with any necessary runoff election to be held on Tuesday, December 3, 2024.

**Section 2.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
