

**RESOLUTION NO. 2024-R-5**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER TO ISSUE  
PURCHASE ORDERS TO HYDRA-STOP, LLC, AS THE  
SOLE SOURCE PROVIDER OF THE HYDRA-STOP  
SYSTEM, IN ACCORDANCE WITH SECTION 7-143 OF  
THE CITY CODE OF ORDINANCES, FOR THE PURCHASE  
OF 4"-12" INSTA-VALVE 250 EQUIPMENT WITH  
HYDRAULIC DRIVE AND POWER PACK, AT A COST NOT  
TO EXCEED EIGHTY-ONE THOUSAND FIVE HUNDRED  
NINETY-SIX DOLLARS (\$81,596.00); PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) is desirous of supporting the Public Works Department’s ongoing efforts to successfully maintain the City’s utility infrastructure by replacing the current water main valve insertion equipment, which needs of repairs, with the new Hydra-Stop System IV 250 Equipment; and

**WHEREAS**, the new Hydra-Stop System is an under-pressure pipe maintenance and repair system engineered to allow the repair and maintenance of water, wastewater, and other fluid systems without interrupting service or requiring system shutdown; and

**WHEREAS**, in accordance with Section 7-143 of the City Code, the Purchasing Director has determined that there is only one (1) reasonable source of the product, and the contract by its very nature, is not suitable to competitive bids or proposal; and

**WHEREAS**, as the sole designer and manufacturer of the Hydra-Stop System, Hydra-Stop, LLC is the sole source provider of the equipment; and

**WHEREAS**, City administration respectfully requests that the Mayor and City Council authorize the sole source procurement of a 4"-12" Insta-Valve 250 Equipment with Hydraulic Drive and Power Pack, at a cost not to exceed Eighty-One Thousand Five Hundred Ninety-Six Dollars (\$81,596.00).

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders to Hydra-Stop, LLC, as the sole source provider of Hydra-Stop System equipment, in accordance with Section 7-143 of the City Code of Ordinances, at a cost not exceed Eighty-One Thousand Five Hundred Ninety-Six Dollars (\$81,596.00).

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
