

RESOLUTION NO. 2024-R-18

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING THE CITY MANAGER'S ISSUANCE OF PURCHASE ORDERS TO CDW GOVERNMENT, LLC, IN THE AMOUNT OF EIGHTY-THREE THOUSAND FIFTEEN DOLLARS AND NINETEEN CENTS (\$83,015.19), FOR THE PURCHASE OF LAPTOPS, TICKET WRITERS, AND PRINTERS FOR USE BY THE NORTH MIAMI POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami (“City”) Police Department is in need of new computer equipment to enhance the police department’s efforts to update its information technology hardware and software for recently hired police officers; and

WHEREAS, on November 28, 2023, the Mayor and City Council adopted Resolution No. 2023-R-217 authorizing the City Manager to take all action necessary to provide for the effective and efficient workings of city government to ensure that the City’s best interests are protected during the recess period; and

WHEREAS, to ensure the purchase of the necessary equipment, the City Manager issued purchase orders in the amount of Eighty-Three Thousand Fifteen Dollars and Nineteen Cents (\$83,015.19) to CDW Government, LLC; and

WHEREAS, the computer equipment was purchased utilizing a contract awarded under RFP No. 081419 issued by Sourcewell, a national cooperative, in accordance with section 7-169 of the City Code of Ordinances; and


WHEREAS, City administration respectfully requests that the Mayor and City Council ratify the issuance of the purchase orders.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Ratification. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the City Manager’s issuance of Purchase Orders in the amount of to Eighty-Three Thousand Fifteen Dollars and Nineteen Cents (\$83,015.19), to CDW Government, LLC for the purchase of laptops, ticket writers, and printers, for use by the North Miami Police Department.

Section 2. **Effective Date.** This Resolution shall become effective immediately upon adoption.
