

RESOLUTION NO. 2024-R-16

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS IN AN AGGREGATE AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000.00) ANNUALLY FOR THE PROVISION OF ORIGINAL EQUIPMENT MANUFACTURER (“OEM”) AND AFTERMARKET PARTS AND SERVICES, UTILIZING MIAMI-DADE COUNTY RTQ NO. PM-EVN0000469; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on March 24, 2023, Miami-Dade County issued *Request to Qualify No. PM-EVN0000469 – Purchase of Original Equipment Manufacturer and Original Equipment Parts and Services* (“RTQ”) a prequalified pool of vendors for the procurement of Original Equipment Manufacturer (“OEM”) and aftermarket vehicle parts, services, and repairs for city vehicles; and

WHEREAS, Miami-Dade County Resolution No. R-640-23 approved an award to various vendors for a term of five (5) years; and

WHEREAS, Section 7-167 of the City of North Miami (“City”) Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods, and/or services from current agreements of other municipalities and governmental entities, such as the Miami-Dade County; and

WHEREAS, City administration respectfully requests approval to use the Miami-Dade County’s contract, procured under *RTQ No. PM-EVN0000469*, for the issuance of Purchase Orders in an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00) annually, to provide the City with OEM and aftermarket parts and services; and

WHEREAS, the Mayor and City Council find that the purchase of this equipment and services is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager to issue purchase orders in an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00) annually, to provide the City

with OEM and aftermarket parts and services, under Miami-Dade County **RTQ No. PM-EVN0000469** pursuant to section 7-167 of the Code of Ordinances.


Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
