

**RESOLUTION NO. 2024-R-46**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE CITY MANAGER AND CITY  
ATTORNEY TO NEGOTIATE AND EXECUTE AN  
AGREEMENT BETWEEN THE CITY OF NORTH MIAMI  
AND AJ CENTER, INC., TO PROVIDE FOR AN  
EXTENSION TO THE PROFESSIONAL TUTORING  
SERVICES PROVIDED AT SUNKIST GROVE  
COMMUNITY CENTER; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami, Florida (the “City”) is desirous of extending the professional tutoring services provided by AJ Center, Inc. (“AJ”) to North Miami students at the Sunkist Grove Community Center, located in District 4; and

**WHEREAS**, AJ is a dedicated organization committed to empowering underserved communities through education and mentorship; and

**WHEREAS**, the tutoring program will continue to focus on providing high-quality academic support for students from low-income backgrounds by improving academic performance, increasing graduation rates, and fostering college readiness; and

**WHEREAS**, AJ has provided tutoring services from November 14, 2023, to March 15, 2024, in the amount of Twenty-Three Thousand Five Hundred Dollars and 00/100 Cents (\$23,500.00); and

**WHEREAS**, the City wishes to extend this partnership with AJ to continue from March 18, 2024, to June 7, 2024, for an additional funding contribution in the amount of Twenty Thousand Eight Hundred Dollars and 00/100 Cents (\$20,800.00); and


**WHEREAS**, the Mayor and City Council find that an agreement for the extension of professional tutoring services provided by AJ Center, Inc. will benefit the residents of the City of North Miami and should be entered into.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY  
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.**      **Authority of the City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with AJ Center, Inc. to provide for an extension to the professional tutoring services currently being provided at Sunkist Grove Community Center.


**Section 2.**      **Effective Date.** This Resolution shall become effective immediately upon adoption.
