

RESOLUTION NO. 2024-R-43

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE EXECUTION OF AN OFF-SYSTEM CONSTRUCTION AND MAINTENANCE AGREEMENT BETWEEN THE CITY OF NORTH MIAMI AND THE FLORIDA DEPARTMENT OF TRANSPORTATION, DESIGNATING AND SETTING FORTH THE RESPONSIBILITIES OF EACH PARTY WITH REGARDS TO THE MAINTENANCE OF ROADWAY IMPROVEMENTS ON STATE ROAD 916 ("135 STREET") FROM N.W. 2 AVENUE TO N.E. 17 AVENUE/TRESSLER STREET; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, Florida Department of Transportation ("FDOT") will be undertaking Project Number FM# 429346-4-52-01 to implement roadway improvements on SR 916 [NW and NE 135 Street from N.W. 2 Avenue to N.E. 17 Avenue/Tressler Street] (the "Project"); and

WHEREAS, a portion of the Project includes work in Ray Cagni Park, in North Miami, Florida, property not on the State Highway System; and

WHEREAS, the Project includes improvements which include installation of landscaping in roadway medians, installation of irrigation in roadway medians, installation of irrigation control components, as well as the installation of irrigation controller, rain sensor, and irrigation control wiring in conduit in Ray Cagni Park; and

WHEREAS, pursuant to the terms of the Agreement, the City will be responsible for reviewing the Project Design Plans and submitting its comments and shall assume all maintenance responsibilities of the local roadways once the Project is completed; and

WHEREAS, the Mayor and City Council find that entering into an Off-System Construction and Maintenance Agreement, in substantially the attached form, for the maintenance and preservation of the roadway improvements, is in the best interest of the City and should be entered into.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF CITY OF NORTH MIAMI, FLORIDA, AS FOLLOWS:

Section 1. Authorization. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the execution of an Off-System Construction and Maintenance

Agreement between the City of North Miami and Florida Department of Transportation, designating and setting forth the responsibilities of each party with regards to the maintenance of roadway improvements on SR 916 [NW and NE 135 Street from N.W. 2 Avenue to N.E. 17 Avenue/Tressler Street].

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
