

**RESOLUTION NO. 2024-R-53**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE COMPETITIVE SELECTION OF M&J CONSULTING GROUP D/B/A M&J GENERAL CONTRACTORS, AS THE LOWEST, RESPONSIVE AND RESPONSIBLE CONTRACTOR TO PERFORM THE BREEZESWEPT PARK AND TOT-LOT RENOVATION & IMPROVEMENTS PROJECT, IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 15-23-24; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH M&J CONSULTING GROUP D/B/A M&J GENERAL CONTRACTORS, FOR THE PROVISION OF SERVICES IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED AND TWENTY-FIVE THOUSAND AND NINETY-FIVE DOLLARS AND SEVENTEEN CENTS (\$425,095.17); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on January 22, 2024, the City of North Miami (“City”) advertised *Invitation for Bid No. 15-23-24 – Breezeswept Park and Tot-Lot Renovation & Improvements Project* (“IFB”), soliciting bids from qualified, licensed, and experienced contractors to requesting bids from licensed and experienced contractors to perform the Breezeswept Park and Tot-Lot Renovation & Improvements Project, in accordance with the specifications and conditions contained in the IFB (collectively referred hereto as “Services”); and

**WHEREAS**, in response to the IFB, M&J Consulting Group d/b/a M&J General Contractors (“Contractor”) submitted its bid and was competitively selected by City administration, as well as the City’s architectural firm, as the lowest responsive-responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

**WHEREAS**, the Contractor has manifested the capability and willingness of providing Services to the City, in accordance with the terms, conditions, and specifications contained in the IFB, at a cost not to exceed Four Hundred Twenty-Five Thousand Ninety-Five Dollars and Seventeen Cents (\$425,095.17); and

**WHEREAS**, the Mayor and City Council have determined that it is in the City’s best interest to approve the selection of a Contractor and hereby authorize the City Manager and City

Attorney to negotiate and execute an agreement for the provision of Services to perform the Breezeswept Park and Tot-Lot Renovation & Improvements Project.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the City administration's ranking and selection of M&J Consulting Group d/b/a M&J General Contractors as the lowest, responsive, and responsible contractor to perform the Breezeswept Park and Tot-Lot Renovation & Improvements Project, in accordance with the terms, conditions, and specifications contained in *Invitation for Bid No. 15-23-24 - Breezeswept Park and Tot-Lot Renovation & Improvements Project*.

**Section 2. Authority of City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the City Manager and City Attorney to negotiate and execute an agreement for the provision of Services with M&J Consulting Group d/b/a M&J General Contractors, at a cost not to exceed Four Hundred Twenty-Five Thousand Ninety-Five Dollars and Seventeen Cents (\$425,095.17).

**Section 3. Effective Date.** This Resolution shall become effective immediately upon adoption.
