

A RESOLUTION NO. 2024-R-72

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO EXECUTE A SECOND AMENDMENT TO THE ASPHALT PAVEMENT REPLACEMENT AGREEMENT WITH METRO EXPRESS, INC., TO INCLUDE ADDITIONAL SERVICES FOR DISTRICT 4, AT A COST NOT TO EXCEED ONE HUNDRED TWO THOUSAND AND SIXTY-TWO DOLLARS (\$102,062.00); PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, in May of 2020, the City of North Miami (“City”) entered into an agreement with Metro Express, Inc. (“Contractors”) for the repair and replacement of asphalt rights-of-way throughout the City; and

WHEREAS, the City is desirous of providing additional asphalt pavement replacement services in District 4; and

WHEREAS, to accomplish this objective, City staff recommends the execution of a Second Amendment to the Asphalt Pavement Replacement Agreement to include additional services related to the following areas: N.W. 127th Street between N.W. 7th and 17th Avenues, and N.W. 10th Avenue between N.W. 119th and 135th Streets; and

WHEREAS, the proposed Second Amendment will provide for additional services at a cost not to exceed One Hundred Two Thousand and Sixty-Two Dollars (\$102,062.00); and

WHEREAS, the City administration respectfully requests that the Mayor and City Council authorize the execution of an amendment to the agreement authorizing the additional services related to the resurfacing of streets in District 4.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority to Execute Second Amendment. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to execute a Second Amendment to the Asphalt Pavement Replacement Agreement with Metro

Express, Inc., to include additional services for District 4, at a cost not-to-exceed One Hundred Two Thousand and Sixty-Two Dollars (\$102,062.00).

Section 2. Effective Date. This Resolution shall be effective upon adoption.
