

Contractual Payment Agreement

This Off-Duty police service Agreement (the "Agreement") is made and entered into this _____ day of _____, 2024, between KSE Group, Inc., Patrick Fabre whose principal business address is 1201 SW 75th Avenue, Plantation, Florida 33317 ("Owner") and the City of North Miami, a Florida Municipal Corporation, whose principal address is 776 NE 125th Street, North Miami, Florida 33161.

1. Purpose:

The purpose of this Agreement is to grant KSE Group, Inc. - Patrick Fabre, permission to have off-duty police security at the Madame Gougousse Soccer games located at the North Miami Stadium, 2555 NE 151 Street, North Miami, without prepayment, for the below dates:

April 14th, 2024

April 21st, 2024

April 28th, 2024

May 5th, 2024

May 12th, 2024

May 19th, 2024 (Final game)

2. Terms and Conditions:

The City of North Miami grants KSE Group, Inc. - Patrick Fabre permission to utilize the designated location of 2555 NE 151st Street, North Miami (North Miami Stadium) for all Madame Gougousse Soccer games from April 14, 2024, to May 19, 2024.

KSE Group, Inc. -Patrick Fabre shall not be required to make any prepayment for the usage of the North Miami off-duty police personnel for the specified period.

KSE Group, Inc. -Patrick Fabre shall ensure that all games are conducted in accordance with the applicable laws, regulations, and guidelines set forth by the City of North Miami.

KSE Group, Inc. -Patrick Fabre shall pay the City of North Miami the total amount for the games conducted, within three (3) weeks after the last game (May 19th, 2024), but no later than June 9, 2024.

3. Acknowledgment:

The signing of this Agreement by KSE Group, Inc. -Patrick Fabre and by the City of North Miami, constitutes acknowledgment and acceptance of the terms and conditions herein.

4. Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida.

7. Entire Agreement:

This Agreement constitutes the entire understanding and agreement between the Parties with respect to the subject matter hereof and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written, between the Parties.
