

RESOLUTION NO. 2024-R-80

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS IN AN AGGREGATE AMOUNT NOT TO EXCEED FIVE HUNDRED FORTY THOUSAND DOLLARS (\$540,000.00) ANNUALLY FOR THE RENTAL OF PUMPS AND RELATED ITEMS, ON AN AS NEEDED BASIS, UTILIZING CITY OF MIAMI BEACH SOLICITATION ITB NO. 2019-156-DF; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on August 23, 2019, the City of Miami Beach issued an *Invitation to Bid No. 2019-156-DF* under a full and open competition; and

WHEREAS, on February 12, 2020, the City Commission of Miami Beach approved the selection and award of *ITB No. 2019-156-DF* to MWI Corporation, Bobcat of Miami, LLC d/b/a Synergy Equipment, and Xylem Dewatering Solutions, Inc, for the rental of pumps and related items, on an as-needed basis, based on Agenda Item C2 E; and

WHEREAS, Section 7-167 of the City of North Miami (“City”) Code of Ordinances authorizes the Interim City Manager to approve the purchase of supplies, goods and/or services from current agreements of other municipalities and governmental entities, such as the City of Miami Beach; and

WHEREAS, City administration respectfully requests approval to use the City of Miami Beach’s contract, procured under *ITB No. 2019-156-DF*, for the issuance of Purchase Orders in an amount not to exceed Five Hundred Forty Thousand Dollars (\$540,000.00) annually, to provide the City with the rental of pumps and related items, on an as-needed basis; and

WHEREAS, the Mayor and City Council find that the purchase of this equipment and services is in the best interest of the City.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders, in an amount not to exceed Five Hundred Forty Thousand Dollars (\$540,000.00) annually, to

provide the City with the rental of pumps and related items, on an as-needed basis, under City of Miami Beach **ITB No. 2019-156-DF** pursuant to section 7-167 of the Code of Ordinances.

Section 2. Effective Date. This Resolution shall become effective immediately upon adoption.
