

**RESOLUTION NO. 2024-R-78**

**A RESOLUTION MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING AND APPROVING THE EXECUTION OF AN EMPLOYMENT AGREEMENT WITH THE INTERIM CITY MANAGER, IN SUBSTANTIALLY THE ATTACHED FORM; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, pursuant to Resolution No. 2024-R-56, the City Manager position for the City of North Miami became vacant effective May 7, 2024; and

**WHEREAS**, pursuant to Resolution No. 2024-R-56, the Mayor and City Council appointed Anna-Bo Emmanuel, Esq. as Interim City Manager to serve in such role while the City engages in the hiring process to retain a permanent City Manager; and

**WHEREAS**, at the time of the aforementioned appointment, Anna-Bo Emmanuel, Esq. was employed by the North Miami Community Redevelopment Agency as the Executive Director, and accepted the appointment as Interim City Manager conditioned upon certain terms and conditions which are set forth in the proposed Employment Agreement; and

**WHEREAS**, the Mayor and City Council desire to execute an Employment Agreement with Anna-Bo Emmanuel, Esq., for the position of Interim City Manager, in substantially the attached form.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.    Approval of Employment Agreement.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize and approve the execution of an Employment Agreement with the Interim City Manager, in substantially the form attached as Exhibit "A".

**Section 2.    Authority.** The Mayor is hereby authorized to execute the Employment Agreement with Ms. Emmanuel on behalf of the City, binding the City to its terms.

**Section 3.    Effective Date.** This Resolution shall become effective immediately upon adoption.
