

**RESOLUTION NO. 2024-R-77**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA, REMOVING  
NIKISHA WILLIAMS FROM THE AFFORDABLE  
HOUSING ADVISORY COMMITTEE (“AHAC”), IN  
ACCORDANCE WITH CHAPTER 2, ARTICLE III,  
DIVISION 1, SECTION 2-32 OF THE CITY OF NORTH  
MIAMI CODE OF ORDINANCES; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the Affordable Housing Advisory Committee (“AHAC”) was established to review policies, procedures, ordinances, land development regulations, and adopted a local government comprehensive plan and will recommend specific actions or initiatives to encourage or facilitate affordable housing while protecting the ability of the property to appreciate in value; and

**WHEREAS**, Chapter 2, Article III, Division 1, Section 2-32, of the City of North Miami Code of Ordinances, provides that appointees may be removed from their appointive position upon motion of the mayor or a member of the council and upon vote of a majority; and

**WHEREAS**, AHAC Committee Member Nikisha Williams has been absent from AHAC meetings for a one (1) year period; and

**WHEREAS**, the Mayor and Council find that it is in the best interest and welfare of the City of North to remove Nikisha Williams as a member of the AHAC due to her lack of attendance at committee meetings.


**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1.      Recitals.** The recitals set forth above are adopted by the Mayor and City Council of the City of North Miami, Florida, and are incorporated herein.

**Section 2.      Removal.** The Mayor and City Council of the City of North Miami, Florida, hereby remove Nikisha Williams from the Affordable Housing Advisory Committee (“AHAC”).

**Section 3.** **Effective Date.** This Resolution shall become effective immediately upon adoption.
