

**RESOLUTION NO. 2024-R-89**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH TETRA TECH, INC., TO PROVIDE DISASTER DEBRIS REMOVAL MONITORING AND OTHER RELATED SERVICES, AT AN ESTIMATED COST NOT TO EXCEED SIXTY HUNDRED FIFTY THOUSAND DOLLARS (\$650,000.00) PER DISASTER EVENT, UTILIZING MIAMI-DADE COUNTY CONTRACT NO. RFP-00172, PURSUANT TO SECTION 7-167 OF THE CITY CODE; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, on January 20, 2016, Miami-Dade County Board of County Commissioners approved the award of *Request for Proposals No. 00172* to Tetra Tech, Inc. as the highest qualified firm based on their extensive experience working with FEMA's Public Assistance program on behalf of public agencies, their significant resources and technical capabilities, including an automated electronic tracking and reporting system to facilitate the monitoring and management of disaster recovery efforts; and

**WHEREAS**, Miami-Dade County has extended the Contract with Tetra Tech, Inc. through December 31, 2025; and

**WHEREAS**, Section 7-167 of the City of North Miami ("City") Code of Ordinances authorizes the City Manager to approve the purchase of supplies, goods and/or services from current agreements of other municipalities and governmental entities, such as the City of Miami Beach; and

**WHEREAS**, City administration respectfully requests approval to use Miami-Dade County's contract, procured under *RFP No. 00172*, for the provision of disaster debris removal monitoring and other related services, in an estimated amount not to exceed Six Hundred Fifty Thousand Dollars (\$650,000.00) per disaster event; and

**WHEREAS**, services provided by Tetra Tech, Inc. will include, but are not limited to, providing oversight and management of debris recovery contractors utilized by the City, field monitoring of debris collection and removal, truck certification, damage assessment, training, assisting staff in communication with FEMA representatives, coordination with the State of Florida and other federal agencies, providing the City with ongoing updates and reports of disaster

recovery efforts, and assisting staff in the submittal of applications for public assistance and awards from FEMA, the State of Florida, and other applicable agencies; and


**WHEREAS**, the Mayor and City Council find that the provision of disaster debris removal monitoring and other related services is in the best interest of the City.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of Interim City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an agreement with Tetra Tech, Inc., for Disaster Debris Removal Monitoring and other related services, at an estimated cost not to exceed Six Hundred Fifty Thousand Dollars (\$650,000.00) per disaster event, under Miami-Dade County Contract No. RFP-00172, pursuant to section 7-167 of the Code of Ordinances.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
