

RESOLUTION NO. 2024-R-94

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
ISSUE PURCHASE ORDERS TO 100FUEGOS LA PERLA
"CORP", IN AN AMOUNT NOT TO EXCEED FORTY-ONE
THOUSAND DOLLARS (\$41,000.00), FOR EXTERIOR
BUILDING REPAIRS, RESURFACING, AND PAINTING
FOR THE POLICE HEADQUARTERS; PROVIDING FOR
AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, the City of North Miami ("City") Police Headquarters is over twenty (20) years old and has not undergone resurfacing or repainting since its construction resulting in the sealings around the windows becoming deteriorated, allowing water intrusion during heavy rains; and

WHEREAS, this deterioration of the building's envelope may result in significant risks to the well-being of the police officers and the continuity of operations; and

WHEREAS, City staff has requested quotes for the completion of the necessary repairs; and

WHEREAS, 100Fuegos La Perla "Corp" has provided a quote for completion of the necessary repairs for an amount not to exceed Forty-One Thousand Dollars (\$41,000.00); and

WHEREAS, City administration respectfully requests approval to issue purchase orders to 100Fuegos La Perla "Corp" for the completion of the work; and

WHEREAS, the Mayor and City Council find that the completion of the necessary exterior building repairs, resurfacing, and repainting of the police headquarters, is in the best interest of the City and its residents.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders, to 100Fuegos La Perla "Corp" in an aggregate amount not to exceed Forty-One Thousand Dollars

(\$41,000.00) for completion of the necessary exterior building repairs, resurfacing and repainting of the police headquarters.

Section 2. Effective Date. This Resolution shall be effective upon adoption.
