

RESOLUTION NO. 2024-R-93

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, AUTHORIZING THE INTERIM CITY MANAGER TO ISSUE PURCHASE ORDERS TO ENVIROWASTE SERVICES GROUP, INC., IN AN AMOUNT NOT TO EXCEED FORTY THOUSAND ONE HUNDRED THIRTY-SIX DOLLARS AND TWENTY CENTS (\$40,136.20), FOR THE PURCHASE AND INSTALLATION OF AN ACCESS HATCH AT THE BANYAN PUMP STATION LOCATED AT THE INTERSECTION OF BANYAN ROAD AND IXORA ROAD; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, the City of North Miami ("City") has requested quotes for the purchase and installation of an access hatch at the Banyan Road Pump Station to comply with the permitting reviews and comments provided by Miami-Dade County's Department of Environmental Resources Management ("DERM"); and

WHEREAS, because the Banyan Road Pump Station is located within a flood zone, DERM requires that the hatch must be watertight and capable of withstanding direct traffic due to its placement; and

WHEREAS, Envirowaste Services Group, Inc. has provided a quote for installation of an access hatch at the pump station for an amount not to exceed Forty Thousand One Hundred Thirty-Six Dollars and Twenty Cents (\$40,136.20); and

WHEREAS, City administration respectfully requests approval to issue purchase orders to Envirowaste Services Group, Inc. for the completion of the work; and

WHEREAS, the Mayor and City Council find that the purchase and installation of the access hatch at the Banyan Road Pump Station, is in the best interest of the City and its residents.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. Authority of Interim City Manager. The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders, to Envirowaste Services Group, Inc., in an aggregate amount not to exceed Forty Thousand One


Hundred Thirty-Six Dollars and Twenty Cents (\$40,136.20) for purchase and installation of an access hatch at the Banyan Road Pump Station.

Section 2. **Effective Date.** This Resolution shall be effective upon adoption.
