

RESOLUTION NO. 2024-R-105

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE AWARD OF V ENGINEERING CORP., AS THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, FOR THE SEPTIC TO SEWER IMPROVEMENTS- PHASE I PROJECT; FURTHER AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT TO COMPLETE THE PROJECT IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED NINETEEN THOUSAND TWO HUNDRED DOLLARS (\$519,200.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 32-23-24; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on March 29, 2024, the City of North Miami (“City”) issued *Invitation for Bid No. 32-23-24 – Septic to Sewer Improvements – Phase I* (“IFB”), soliciting bids from experienced and qualified contractors to furnish all labor, equipment, materials and expertise required to complete Phase I of the Septic to Sewer Improvements Project, in accordance with the terms, conditions and specifications contained in the IFB (“Services”); and

WHEREAS, in response to the IFB, the City received and opened four (4) bids on May 17, 2024; and

WHEREAS, V Engineering Corp. (“Contractor”), was determined to be the lowest responsive and responsible bidder, with qualifications and references demonstrating to be the most advantageous to the City in the provision of Services; and

WHEREAS, the scope of work for the project (“Project”) consists of making improvements to the sanitary sewer system to provide for septic tank conversions to the City’s sanitary sewer system in an effort to reduce water pollution, reduction of sanitary sewer outflows, and reduced risk of polluting the ground water source and Biscayne Bay; and

WHEREAS, the Contractor has manifested the capability and willingness of providing Services to the City for a total project cost not to exceed Five Hundred Nineteen Thousand Two Hundred Dollars (\$519,200.00); and

WHEREAS, City administration respectfully requests that the Mayor and City Council approve the bid award of the Contractor and further authorize an agreement for the completion of Services.

NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Bid Award Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the award of V Engineering Corp., as the lowest responsive and responsible contractor to perform the Septic to Sewer Improvements Project – Phase I.

Section 2. **Authority of Interim City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an agreement to complete the project in an amount not to exceed Five Hundred Nineteen Thousand Two Hundred Dollars (\$519,200.00), in accordance with the terms, conditions, and specifications contained in *Invitation for Bid No. 32-23-24 – Septic to Sewer Improvements – Phase I.*

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
