

RESOLUTION NO. 2024-R-101

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA, RATIFYING
THE “DECLARATION OF A STATE OF EMERGENCY”
IMPOSED BY THE INTERIM CITY MANAGER ON JUNE
12, 2024, DUE TO LOCALIZED FLOODING; PROVIDING
FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, in the early hours of June 11, 2024, Invest 90L, a broad area of low pressure, began moving across the Florida Peninsula producing severe weather, widespread heavy rainfall with totals of 10 to 15 inches, and consequential flooding across portions of South Florida; and

WHEREAS, the City of North Miami (“City”) faced dangerous conditions of sufficient severity and magnitude to warrant coordinated local government action to prevent or alleviate the damage, loss, hardship, or suffering threatened or caused thereby; and

WHEREAS, County Mayor Daniella Levine Cava declared a State of Emergency for Miami-Dade County due to a multi-day, intense, rainfall event, which flooded local roadways throughout the County; and

WHEREAS, Governor Ron DeSantis declared a State of Emergency under Executive Order No. 24-115 for Broward, Collier, Lee, Miami-Dade, and Sarasota counties due to the rainfall and flooding which affected the operational capability of critical infrastructure, including major interstates, state and county roadways, airports, schools, and other critical infrastructure throughout these counties; and

WHEREAS, these weather conditions caused a condition of peril of life and property necessitating the proclamation of the existence of an emergency and in accordance with section 2-419 of the North Miami Code of Ordinances, the Interim City Manager declared a state of emergency due to hurricane; and

WHEREAS, the emergency dangers and threats of the flood conditions have passed, and in accordance with section 252.38(4)(c) of the Florida Statutes, the Emergency Order has expired.

**NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY
COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

Section 1. Ratification of Declaration of State of Emergency. The Mayor and City Council of the City of North Miami, Florida, hereby ratify the "Declaration of State of Emergency" imposed by the Interim City Manager on June 12, 2024, attached as Exhibit "A."

Section 2. Authority of Interim City Manager. The Interim City Manager is hereby authorized to do all things necessary to effectuate the terms of this resolution.

Section 3. Effective Date. This Resolution shall become effective immediately upon adoption.
