

**RESOLUTION NO. 2024-R-113**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL  
OF THE CITY OF NORTH MIAMI, FLORIDA,  
AUTHORIZING THE INTERIM CITY MANAGER TO  
EXECUTE AN INTERLOCAL AGREEMENT BETWEEN  
THE CITY OF NORTH MIAMI AND MIAMI-DADE  
COUNTY TO PROVIDE FOR ON-DEMAND  
TRANSPORTATION SERVICES; PROVIDING FOR AN  
EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, the City of North Miami (“City”) wishes to enhance local mobility through the provision of dynamically routed on-demand transit service; and

**WHEREAS**, pursuant to Section 212.055(1)(d), Florida Statutes, transportation surtax proceeds may be used for on-demand transportation services; and

**WHEREAS**, Section 29-124 of Miami-Dade County (“County”) Code of Ordinances further allows eligible municipalities to use their municipal share of surtax proceeds for the provision of on-demand transportation services where a trip is not greater than five (5) miles in distance; and

**WHEREAS**, the City has proposed and is willing to provide, an alternative form of supplemental public transportation throughout the City, to be funded by its share of twenty percent (20%) surtax as provided by Section 29-124 of the County Code; and

**WHEREAS**, the City desires to approve an Interlocal Agreement with the County, in substantially the form attached as Exhibit “A”, relating to the operation of the City’s on-demand transit services for residents and visitors of the City; and

**WHEREAS**, the Mayor and City Council find that entering into an Interlocal Agreement with Miami-Dade County to provide for an on-demand transit service is in the best interest of the City and its residents.


**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to execute the Interlocal

Agreement between the City of North Miami and Miami-Dade County, in substantially the form attached hereto as Exhibit "A", to provide for on-demand transportation services.

**Section 2. Effective Date.** This Resolution shall become effective immediately upon adoption.
