

RESOLUTION NO. 2024-R-116

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL
OF THE CITY OF NORTH MIAMI, FLORIDA,
AUTHORIZING THE INTERIM CITY MANAGER TO
ISSUE PURCHASE ORDERS IN AN AGGREGATE
AMOUNT NOT TO EXCEED FIVE HUNDRED AND FORTY
THOUSAND DOLLARS (\$540,000) ANNUALLY FOR THE
PURCHASE OF PUMPS, DRIVES AND MOTORS PARTS
AND SERVICES, PIGGYBACKING MIAMI-DADE
COUNTY SOLICITATION NO. EVN000292; PROVIDING
FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

WHEREAS, on April 11, 2023, Miami-Dade County (“MDC”) issued an *Invitation Request to Qualify No. EVN000292* (“RTQ”) to establish a pre-qualified pool of vendors capable of providing pumps, drives, motors (inclusive of parts and ancillary equipment), and related goods and services; and

WHEREAS, effective November 1, 2023 through October 31, 2028, MDC has established a pool of pre-qualified vendors to supply units, parts, supplies, and repairs for pumps, drives, and motors; and

WHEREAS, Section 7-167 of the City of North Miami (“City”) Code of Ordinances authorizes the Interim City Manager to approve the purchase of supplies, goods, and/or services from current agreements of other municipalities and governmental entities, such as MDC; and

WHEREAS, City administration respectfully requests approval to piggyback MDC Solicitation No. EVN000292 for issuance of Purchase Orders in an amount not to exceed Five Hundred and Forty Thousand Dollars (\$540,000) annually, to provide the City with pump, drives, and motors parts and services; and

WHEREAS, the Mayor and City Council find that the purchase of this equipment is in the best interest of the City and should be approved


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Authority of Interim City Manager.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager to issue purchase orders in an amount not to exceed Five Hundred and Forty Thousand Dollars (\$540,000) annually, to


provide the City with pumps, drives, and motors parts and services, piggybacking MDC Solicitation No. EVN000292.

Section 2. **Effective Date.** This Resolution shall be effective immediately upon adoption.
