

RESOLUTION NO. 2024-R-123

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, APPROVING THE SELECTION OF COUNTRY BILL'S LAWN MAINTENANCE, INC., AS THE LOWEST RESPONSIVE & RESPONSIBLE BIDDER TO PROVIDE CITYWIDE ALLEYWAY MAINTENANCE AND CLEAN-UP SERVICES; AND FURTHER AUTHORIZING THE INTERIM CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND EXECUTE AN AGREEMENT AT A COST NOT TO EXCEED FORTY-THREE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$43,250.00), IN ACCORDANCE WITH THE TERMS, CONDITIONS, AND SPECIFICATIONS CONTAINED IN INVITATION FOR BID NO. 58-23-24; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.

WHEREAS, on July 5, 2024, the City of North Miami (“City”) issued *Invitation for Bid No. 58-23-24 Citywide Alleyways Maintenance and Clean-up Services* (“IFB”), for the purpose of obtaining bids from qualified and experienced companies to provide all necessary labor, materials and supervision for Citywide Alleyway Maintenance and Cleanup services, in accordance with the terms, conditions and specifications contained in the IFB (“Services”); and

WHEREAS, in response to the IFB, Country Bill’s Lawn Maintenance, Inc. (“Contractor”), submitted its sealed bid and was subsequently evaluated by City administration as the lowest responsive, responsible bidder whose bid, qualifications, and references demonstrated to be the most advantageous to the City in the procurement of Services; and

WHEREAS, the Contractor has expressed its capability, expertise, and willingness to perform the Services pursuant to IFB requirements, for a term of one (1) year with two (2) options to renew for an additional one (1) year term, at a cost not to exceed Forty-Three Thousand Two Hundred Fifty Dollars (\$43,250.00); and

WHEREAS, the Mayor and City Council have determined that it is in the City’s best interests to approve the selection of the Contractor and authorize the Interim City Manager and City Attorney to negotiate and execute an agreement with the Contractor for the provision of Services at various locations throughout the City.


NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:

Section 1. **Selection Approval.** The Mayor and City Council of the City of North Miami, Florida, hereby approve the selection of Country Bill's Lawn Maintenance, Inc., in accordance with the terms, conditions, and specifications contained in the *Invitation for Bid No. 58-23-24 Citywide Alleyways Maintenance and Clean-up Services*, to provide Citywide Alleyway Maintenance and Cleanup services, in accordance with the terms, conditions and specifications contained in the IFB.

Section 2. **Authority of Interim City Manager and City Attorney.** The Mayor and City Council of the City of North Miami, Florida, hereby authorize the Interim City Manager and City Attorney to negotiate and execute an agreement with the Contractor for a term of one (1) year with two (2) options to renew for additional one (1) year periods, at a cost not to exceed Forty-Three Thousand Two Hundred Fifty Dollars (\$43,250.00).


Section 3. **Effective Date.** This Resolution shall become effective immediately upon adoption.
